• City-wide solar power presentation – National Energy Partners  
Mr. Conner addressed the group. He said he’s basically talking about a power purchase agreement. He said for the most part the place to put solar panels is on roof tops. He said people are moving fast on this, and certain approvals need to be put in place in order to move forward. The Administrator asked what the time frame is for moving forward and completing the job. Mr. Conner said 6-9 months, so that it could be completed by the end of the year. The Mayor asked what kind of savings on electric could be expected. Mr. Conner said roughly 30-50 percent savings. The Mayor asked if it includes roof replacement. Mr. Conner said no. The Administrator asked for a more specific proposal. Mr. Conner said there are no up-front costs to the City.
