R. Troiano, Leaming Ave. – Said he's there on behalf of FMBA 50, the fire dept. union. He spoke about Resolution I re: possible island-wide fire dept. and associated grant. He said no one's against consolidation of services, be he's concerned that the way things are done in Wildwood is not the way other towns operate. The Mayor said it's just a feasibility study, and that there's nothing going on to undermine the fire dept. Comm. Fitzsimons said she's here to protect the City's interest and have a level playing field.

Karen Burke – Said communication is the key, and to let everybody know the study is happening.

K. Houser, Davis Ave. – Wants everyone to know that Wildwood will be a success with this study.
