V. Nickels – Asked the Board about the audit. The Mayor said that professionals were appointed at tonight's meeting, and the first goal is to get the 2020 budget completed.

At this time, the Mayor asked the Chief of Police to update the public on the President's upcoming January 28<sup>th</sup> trip to Wildwood. The Chief said they're expecting more than 25,000 people for the event. He said his Department is working in unison with local, state and federal officials to make the President's visit as smooth and safe as possible. He said there will be restrictions on where people can walk, and what they can bring into the Convention Center with them. K. Burke – Asked when the Pacific Ave. project is going to commence.
