Al Brannen, 217 E. Bennett Avenue: Mr. Brannen questioned if the pumps are working on Leaming Avenue. Jim Oris states they are working and did well through the recent storm. Mr. Brannen states Bennett and Pacific

Avenues flooded Tuesday night and Commissioner Mikulski explained Public Works was out at 6:00am working diligently to aid this issue by removing debris from the backed up sewer grates. Mr. Brannen says he would like for the pump station to be painted before summer time along with suggesting the Regular Meetings now be held at 7:00pm. Mayor Troiano stated they would be taking a good look at the pump station and wants it done properly the first time and explained that meetings were previously held at 7:00pm and 6:00pm and the public was not attending which is why they are now conducted at 5:00pm. Mr. Brannen asks the Board to consider placing television screens for Planning & Zoning so the public can know what is going on. Lastly, Mr. Brannen states that he does not want a local who is favored to be put in place as Administrator and asks the Board of Commissioners to take this into consideration as well. Mr. Brannen noted he could provide a phone number of a potential Administrator. Mayor Troiano directed Mr. Brannen to provide the City Clerk with that information at the conclusion of the meeting.

<u>Christopher D'Amico, 121 W. Magnolia Avenue</u>: Mr. D'Amico adds to Brannen's statement in regards to the pump and states that the pump project is not yet complete and that it is still relying on the old infrastructure.
