Dan MacElrevey, Doo Wop Preservation League President – Said he was in attendance to provide the Board with an update from the League. He handed out assorted materials that reflected the League's number for 2018. He said nearly 2,000 people have signed the League guestbook this year. He said there's been a lot of good public relations efforts lately, with the City featured on the Travel Channel, among other things. He thanked the City, Chamber of Commerce and GWTIDA for their efforts.

Ben Rose, GWTIDA –Echoed the sentiments of Mr. McElrevey. He said there have been 123 feature stories written on the Wildwoods this year, which translates into nearly \$4 million in ad revenue.

Steve Tecco, Hotel Motel Assocation – Said he's here with a positive comment. He thanked the City for its partnership in helping to extend the shoulder seasons, for more revenue opportunities. He said the Wildwoods is a fun place, and thanked the City for its help.

T. Williams, Doo Wop Preservation League – Said the League is doing tours by bus three days a week and that it's a big success. She said they've had to increase tours this past summer.

Frank Nave, Wildwood – He said Wildwood has a proud history and asked others to celebrate that history. He said we're not Avalon or Cape May. He said he loves it here.
