•Engineer's Report – Jim Oris – Remington & Vernick: Report on file in the City Clerk's Office. Mr. Oris, as well as the contractor, have been handling all concerns from Ocean Towers. Commissioner Mikulski asked if Mr. Oris has looked into the slope issue on West Burk Avenue relative to the Phase 2A project. Mr. Oris did speak with the property owner and discussed the options to resolve the issue. Mayor Byron asked for an update relative to the bulkhead/flooding issue on West Burk Avenue. Mr. Oris said this area

has experienced flooding for quite some time. The owner of the Wharf had been working on the bulkhead since May of last year, but has stopped short due to lack of contractors. Remington & Vernick has had multiple meetings with the owner however, no work has been completed. Remington & Vernick is currently waiting on a price from the contractor and will charge the owner accordingly. Mayor Byron asked for a timeframe for completion. Mr. Oris said there is a 10-14 day delay for materials and is estimating a 60 day timeframe until completion.
