RESOLUTION AUTHORIZING THE ADVERTISEMENT AND NOTICE TO BIDDERS OF THE ATLANTIC AVENUE STORM SEWER IMPROVEMENTS PROJECT

WHEREAS, the City of Wildwood (the "City) wishes to advertise and receive bids for construction and related services as needed for the Atlantic Avenue Storm Sewer Improvements project; and

WHEREAS, the aggregate of said goods and services requested is anticipated to exceed the current bid threshold, and is therefore required to be bid under a formal process pursuant to Local Public Contracts Law N.J.S.A. 40A:11-3 et seq.; and

WHEREAS, the City has appointed the firm of DeBlasio & Associates to prepare the Bid Specifications, Notice to Bidders, Proposals and Specifications for the aforementioned services in anticipation of public bidding, annexed hereto and incorporated by reference herein, and the Board of Commissioners, the Governing Body of the City has determined the same to be acceptable for public bidding,

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners, the Governing Body of the City of Wildwood, County of Cape May, State of New Jersey as follows:

- 1. That the provisions of the above preamble of this Resolution are hereby incorporated herein, by this reference, as if set forth at length.
- 2. That the City Clerk is hereby authorized and directed to advertise bids for the Atlantic Avenue Storm Sewer Improvements project as set forth in the Specifications and Bid Materials, incorporated by reference herein.
- 3. That the Notice to Bidders be published in a legal newspaper of the City of Wildwood not less than ten days prior to the date fixed for receipt of bids, and that revisions, if necessary, be published and made available by written notice sent certified mail no later than seven days, Saturdays, Sundays and holidays excepted, prior to the date for acceptance of bids to any person who has submitted a bid or received a bid package.
- 4. That bids shall be submitted to the City Clerk at 4400 New Jersey Avenue, Wildwood, NJ 08260 no later than Thursday, March 21, 2024 at 10:00 am.

NOTICE TO BIDDERS

Notice is hereby given that sealed proposals will be received by the Municipal Clerk, City of Wildwood, Cape May County, New Jersey for the Atlantic Avenue Storm Sewer Improvements opened and read in public at the City of Wildwood Municipal Building, 4400 New Jersey Avenue, Wildwood, Cape May County, New Jersey on March 21, 2024 at 10:00 a.m. prevailing time.

Bid Documents and Drawings for the proposed work, which have been prepared by DeBlasio & Associates, P.C., are available at the office of said Engineer at 4701 New Jersey Avenue, Wildwood, New Jersey 08260, and may be inspected by prospective bidders during business hours.

Bidders will be furnished with a copy of the Bid Documents by request upon proper notice and payment of a non-refundable charge of \$75.00 payable to DeBlasio & Associates, P.C., for reproduction and processing.

Proposals must be made on the standard Proposal Forms in the manner designated in the Bid Documents, must be enclosed in sealed envelopes bearing the name and address of the Bidder, and the name of the work on the outside addressed to **Clerk, City of Wildwood**; and must be accompanied by a statement of Consent of Surety from a surety company authorized to do business in the State of New Jersey and acceptable to the City and either a Bid Bond, Certified or Cashier's Check drawn to the order of the **City of Wildwood** for not less than ten percent (10%) of the amount bid, except that the check need not exceed \$20,000.00. The successful bidder is hereby notified that a performance bond for the full amount of the project is required.

The successful bidder will be required to execute a contract for the performance of the said work or the furnishing of said material or both, as the case may be, and a surety bond to be executed by a reliable surety company in a sum equal to the amount of the contract price for said work and/or material, guaranteeing the performance of the contract, which surety bond and contract shall be approved as to form and execution by the City Solicitor.

The bidders shall also be required to comply with the following:

The award of the contract for this project will not be made until the necessary funds have been provided by the **City of Wildwood** in a lawful manner. The **City of Wildwood** reserves the right to consider the bids for sixty (60) days after the receipt of said bids. The **City of Wildwood** also reserves the right to reject any or all bids or to waive any informalities in the best interest of the **City of Wildwood**.
