<u>PUBLIC COMMENT:</u> During regularly scheduled Board of Commissioners Meeting.

Remarks will limit to five (5) minutes per person. The Deputy City Clerk will be keeper of time and advise speaker when time has expired. Each member of the public will be permitted to speak only once per meeting. Criticism of public employees will be directed to the Human Resources Department during work hours only.

Ryan Troiano - 201 W. Learning Avenue: Mr. Troiano stated that the Morey's are using the backs of the lifeguard stands to advertise their businesses and asked how much they paid the City to use the spaces. Commissioner Leonetti said they aren't paying anything, and that this is being done as a pilot plan. Commissioner Leonetti said that if this works this year, next year the City will bid out the spaces for advertising purposes. Mr. Troiano stated he had previous submitted an advertisement plan and it was turned down. He said it's a bad idea to allow free advertisement when the City is suffering financially. Mr. Troiano feels this is "sketchy" as no one knew that Commissioner Leonetti was allowing this and made this decision without conferring with the other Commissioners. Both Mayor Troiano and Commissioner Byron said they didn't know anything about this matter. Mayor Troiano said he is not in favor of this but it is Commissioner Leonetti's department. Mayor Troiano guaranteed that this will not be the case next year and as he believes everyone should have to pay for advertising. Commissioner Byron said he is surprised a decision was made without letting the other Commissioners know and that he's totally against it. Mr. Troiano moved on and said he was displeased about being called out by the Administrator at the last meeting. Ms. Bittner interjected and advised the Board that this was a personnel matter and should not be discussed during public comment. Mayor Troiano told Mr. Troiano that he (Ryan Troiano) is a City employee and this should be handled by the Director of Human Resources and is not to be discussed on the floor. Mr. Troiano said, as a resident and tax payer of Learning Avenue he wants the Administrator to step down. Commissioner Leonetti told Mr. Troiano again, that this is a matter of personnel and is not to be discussed here. Mr. Troiano said that he is still a tax payer and employees for the City are afraid to follow through on things because they are afraid of retaliation. Mr. Troiano said he pays more money in taxes than Commissioner Leonetti, Mr. Fox and Ms. Bittner. Mayor Troiano told Mr. Troiano that he forfeited his right to speak on this matter when he became an employee of the City and that his recourse is to take his issue to the Department of Human Resources. Mayor Troiano called on William Blaney, Labor Council, who stated, he was working on this issue. Mayor Troiano said, anyone working for the City of Wildwood wishing to discuss another City employee cannot not happen. Mr. Troiano said, if there is an issues that affects the tax payers, it should be addressed.
