# **COMMUNICATIONS:**

•Best Practice Inventory- The City Clerk said every year the City of Wildwood is tasked with completing the Best Practice Inventory consisting of 70 questions. Municipalities must obtain a score of at least 32 in order to receive 100% of its 2025 State Aid. The city received a score of 38.50 thus resulting with the city receiving 100% of said State Aid.

**NEW BUSINESS:** None.

**PUBLIC COMMENT:** During regularly scheduled Board of Commissioners Meeting. Remarks will limit to five (5) minutes per person. The City Clerk will be keeper of time and advise speaker when time has expired. Each member of the public will be permitted to speak only once per meeting. Criticism of public employees will be directed to the Human Resources Department during work hours only.

Carl Schmoyer, 5301 Ocean Avenue: Mr. Schmoyer commented on the Bennett Avenue project, the old Winward Motel saying he was concerned about the pitched roof and noted it was going from 25 units down to 14. He said that he's not happy to see another motel go but he would never dispute anyone's plans. Mayor Troiano said the City is looking at other developers to come in and look at Splash Zone. He also said the City has been in contact with a number of large developers for large scale buildings. Mayor Troiano said he doesn't want to be another Avalon or Stone Harbor and that we need the turnover. Mr. Schmoyer asked how we made out with the storm. Mayor Troiano said we gained more beach. He also stated that people complained about the water. You're not going to stop a storm or water, you live on a barrier island and have to expect flooding. Commissioner Mikulski said the City of Wildwood was well prepared for it. Mayor Troiano said if the State really wants to help the Wildwood's they should build a 12ft bulkhead around the entire barrier. Mayor Troiano said the state is now going to look at the flooding occurring in the back bay area. Mr. Schmoyer asked the status

for the Leaming Avenue pump station. Mayor Troiano stated that the city will most likely be in litigation and in his opinion, it should be ripped out and redone. The city is estimating at least \$22,000.00 to cut the existing concrete just to reach the filters.
