Mayor Troiano said initially the budget was at 24 cents and is now down co. Administrator Ed Grant said this budget was not only built for this year but for the future budget as well. Mayor Troiano thanked the City Clerk and Administrator for the level of professionalism they've brought to the City.

REPORTS:

•Engineers Report – On file in the City Clerk's Office. Mr. DeBlasio noted the Bennett Avenue Beach Street End Improvement Project is progressing on schedule and will be open in advance of summer. In reference to the NJDOT Local Transportation Project Fund, New York Avenue, DeBlasio & Associates will be submitting the specifications to DOT by next Tuesday or Wednesday with bid opening slated for the Spring. Work will begin in the summer while school is not in session. Design drawings and specifications have been submitted to the I-Bank for the Capital Improvement Plan – Phase 3. We are now waiting on permission to advertise. Bid opening for this project is planned to take place by May 30, 2025. In regard to FY2025 Lead Service Line Replacement, DeBlasio & Associates have completed the GIS Conversion and will be meeting with the Water Utility to review the program. The Water Utility is waiting for setters to be received in regard to Contract No. 1, and Contract No. 2 will be uploaded to I-Bank in the next 2-3 weeks and slated to advertise for construction in May.

ANNOUNCEMENTS: Commissioner Mikulski noted the boardwalk has been undergoing major renovations throughout the winter but assured the public that the Boardwalk will be open for Easter, with the exception of the newly extended portions of the Boardwalk housing the new pavilions. These areas will be closed to the public as they are not yet complete. Commissioner Mikulski said along with the Boardwalk renovations, the City has purchased state of the art cameras which will be installed at each street end. Commissioner Mikulski also announced the Superior Officers Association contract has been approved and thanked everyone for their efforts in the completing the contract.

OLD BUSINESS: Mayor Troiano announced the Leaming Avenue Pump Station is having issues that the City has not been able to rectify. Some of the problems at hand are the inability to get to the floats which are chambered and encased. Mayor Troiano said the City would have to cut holes in the concrete in order to access them. There are four pumps that turn on all at the same time when not needed causing additional electrical costs to the City. The City cannot access the trash gates to clean out the area when needed without sending an employee 20ft deep to access them. There are further issues such as warning bells being triggered and with the design itself. The cost of this pump station was \$23 million so discussions have to be had with the engineer and the contractor to make these repairs once and for all.

PUBLIC COMMENT: During regularly scheduled Board of Commissioners Meeting. Remarks will limit to five (5) minutes per person. The City Clerk will be keeper of time and advise speaker when time has expired. Each member of the public will be permitted to speak only once per meeting. Criticism of public employees will be directed to the Human Resources Department during work hours only.

Ed Quigly, 5521 Cottage Street, St. Richmond, VA: Mr. Quigly was involved in a tragic accident wherein he was impaled by an umbrella which almost caused him to lose his life. Since then he's become involved with a task group who develops beach umbrella safety standards. Mr. Quigly offered to provide the City, at no cost,

with warning signs to post at all beach access points to warn beachgoers of the dangerous risks associated with umbrellas that are not correctly secured. The signs would also provide beachgoers with the correct way to secure umbrellas in the sand and how to anchor them so they won't blow away when winds are high. Mayor Troiano said he would look into it and provide him with a count of how many signs the City would need.
