EARLY PUBLIC COMMENT LIMITED TO RESOLUTIONS ONLY:

Jennifer Wetzel, 210 W. Maple Avenue: Ms. Wetzel asked if there has ever been recycling bins on the Boardwalk. Commissioner Mikulski said, they are located by the bathrooms however, not along the Boardwalk. Commissioner Fitzsimons said the City has added more trashcans due to COVID however; recycling cans will be harder to find. Ms. Wetzel said she has noticed many markings on Maple Avenue and asked if there is going to be work going on, on her street. Christopher D'Amico said the gas company is doing preliminary work for

future EVO valves, with no start date set as of yet. As soon as the City is aware of a start date, they will advise everyone. Commissioner Fitzsimons noticed they were doing work on the poles as well. Mr. D'Amico said they are doing termite control by inspecting the polls. Ms. Wetzel requested the City place a "stop" line on Maple Avenue and the intersection of New York Avenue in an effort to reduce traffic from flying down the street. Commissioner Mikulski said he would address it.

Debbie Sweeney, 101 W. Poplar Ave: Ms. Sweeney said she had several issues to report. First, she noticed she had missing items in her yard. Upon contacting the Police, she was told to install cameras, which she believed to be an unacceptable answer. She said the issues stem from the property located at 103-105 W. Poplar Avenue. On one occasion, she found a young man passed out on her porch and notified the Police. She said the Police never arrested him, just released him to his parents and the individual was back in the house next door 6 hours later. She has located a 14-year-old run away located at the same property. She has found another person sleeping in her yard, and has also contacted the Police for a fistfight and a noise complaint however, the Police never showed up. Commissioner Mikulski asked if this property was a seasonal property or year round property and if she knew who the owner was. She said, it is operated as a yearly rental and the owners name is Jacek Bartha. Ms. Sweeney is also concerned about the overgrown grass and debris in the neighboring properties. Commissioner Mikulski said he would address these issues with both Police and Code Enforcement.
