•Engineers Report – On file in the City Clerk's Office. Mr. Chadwell stated he would have the traffic study report for Park Boulevard and Atlantic Avenue by tomorrow. He reported the concrete work at the Sightseer is being done and conduits were incorporated. Commissioner Fitzsimons said the work done has been a major improvement. Mr. Chadwell said they found valve that was consistently kept open by the tide, which is now capped and abandoned. Commissioner Fitzsimons asked if the flooding issue would be resolved by capping and

abandoning that valve. Commissioner Mikulski said, it would not solve the flooding problem.

PUBLIC COMMENT: During regularly scheduled Board of Commissioners Meeting. Remarks will limit to five (5) minutes per person. The City Clerk will be keeper of time and advise speaker when time has expired. Each member of the public will be permitted to speak only once per meeting. Criticism of public employees will be directed to the Human Resources Department during work hours only.

<u>Kevin Murray, 210 W. Davis Avenue:</u> Mr. Murray is concerned about the safety of those needing to access the handicapped accessible sidewalk ramps on Park Boulevard near Davis Avenue. He requested the handicapped accessible sidewalk ramp be moved by 5ft. Mr. Chadwell said the City is currently doing a traffic study on Park Boulevard and if moving of the ramp were approved, it would take time.

Kathy McCullough, 415 W. Cresse Avenue: Ms. McCullough asked what changes were being made to the Land Development Ordinance. Mr. DeLollis said they are just cleaning up the Ordinance in terms of modifying definitions and is not pertaining to development in any way. Ms. McCullough believed the BID and SID to be independent entities and asked why the City of Wildwood was contributing fees. Mr. O'Connor explained the City of Wildwood partners with the BID and SID for certain projects. The project she is referring to specifically is being funded through the NPP while others are funded through UEZ. Commissioner Fitzsimons explained both BID and SID fund themselves. She directed Ms. McCullough to attend meetings held by the BID and SID if she had concerns regarding their budget. Ms. McCullough had questions regarding UEZ which were answered by Mr. O'Connor who explained that UEZ can decide where they would like to invest their funds which is then approved by the City as well as the DCA. Ms. McCullough was concerned about the amount of this meetings bill list. Commissioner Fitzsimons said the bill list averages around \$3 each meeting. Some bill lists are higher depending on what bills are being paid. Ms. McCullough mentioned her property tax has increased. Mayor Byron said new construction is the best way to stabilize taxes but it could take time to receive the full amount of ratables. Ms. McCullough asked why her street continues to flood. Mr. Chadwell explained the water is coming from Morning Glory Road, which is in Wildwood Crest. He said Wildwood Crest would need to do improvements in order to alleviate the flooding on her street. He welcomed Ms. McCullough to review the plans again if she wished.

ADJOURNED: There being no further business to discuss, this meeting was adjourned at 5:28 pm. Remarks as typed highlighted not verbatim as to subject matter.
