The Mayor said he's done nothing wrong, and that similar leases have been approved for other organizations like the Historic Society.

Sandra Richardson, Lake Rd. – Also asked questions about Resolution D. She asked who puts up the money. The Mayor said the organization (East Coast) does. She asked about a guarantee in writing, and said she thinks the City is getting "burned big time."

Ryan Troiano, Leaming Ave. – Also has concerns about the lease of the building. He said no

one's here from the organization to explain the proposal. He said the City needs a new approach. Commissioner Byron said the project is never going to happen, that it's a pipe dream of the Mayor's. He said the City is being sold short - again. The Mayor said he'll take his chances.

Al Brannen, Bennett Ave. - Said it makes him sad that the Historic Society is getting dragged into this. He said the Historic Society is not hurting for money.

Kathy Distro, 26^{th} St. – Said her most recent tax bill almost killed her. She said people can only afford so much. She said the City has to be assessed properly. She also complained about mixed zoning uses in the City.
